## Digital Dispatch Finalizes Details of MobiSoft Acquisition

**Richmond, BC, October 1<sup>st</sup>, 2007** – Digital Dispatch Systems Inc. ("Digital Dispatch") (TSX: DD), a leading provider of mobile data solutions, announced today that the closing of the acquisition of all of the shares of Mobisoft Oy ("Mobisoft") will occur on October 5<sup>th</sup> 2007 and will be effective October 1<sup>st</sup> 2007. The acquisition is being done through the Company's UK subsidiary.

The two companies have mutually agreed to fix the number of shares issued as part of this transaction at 1,280,000 shares and these shares will be issued subject to a 4 month hold period. After issuing these shares, Digital Dispatch will have a total of 13,143,201 shares issued and outstanding.

The total consideration for the transaction has been revised downward to €5.17 million payable by €3.0 million in cash and 1.28 million common shares issued from treasury valued at €2.17 million (based on an exchange rate of 1.4164 CDN\$ per Euro and CDN\$2.40 per Digital Dispatch share).

In addition, the Company is issuing 200,000 stock options, vesting over a period of three years with an exercise price of CDN\$3.00, to the employees of Mobisoft to purchase Digital Dispatch common shares from treasury from its existing Employee Stock Option Plan.
